Hour Exchange Portland has been strengthening the national service exchange/time bank model since its inception in 1996. The project described herein will initially be offered to the 600 plus membership of Greater Portland; however, as a state and national training center, the project's design, management and evaluation will be translated to a curricula for training of existing and new time bank/exchanges throughout Maine and the country. (Please see attached history.) With the support of Bangor Savings Bank our social architect will work with and hire a qualified Americorps*VISTA Worker for a year of service to formalize the development of an organically inspired microenterprise program for our members. This program has two worthy goals:

- a. to support and promote its members in successful microenterprise-small business development that will improve their quality of life and income earning potential and;
- <u>b.</u> assure the financial sustainability of HEP through the partnerships an profit sharing of the entrepreneurs sales.

HEP's microenterprise project is a natural outcome of its members. Members start

businesses in which some products or services are sold for time, and some for cash. This supports both the cash economy and social capital as neighbors help neighbors. Successful examples of business growth by members in HEP include:

- Time & Talents software: created by a HEP member for time bank/exchanges, it is now sold to sites through our training center. Sales projections for 2010 are expected to increase by 100%, with 50% of profits returned to HEP as a donation.
- Portland First Friday Art Walk: Members showcase their art in the heart of the city's art district. Art exposure and sales benefit the artist-members, with 20% commission returned to HEP for marketing. (Continued on attachment)
